## 6B47 AG: Supervisory Board lays the foundation for the future

- Departure of Peter Ulm on 30 September 2019
- Sebastian Nitsch and Friedrich Gruber ensure continuity
- Germany boss Kai-Uwe Ludwig moves up in the AG Management Board

Vienna, 26 June 2019. The Supervisory Board of the real estate developer 6B47 Real Estate Investors AG operating on an international scale lays the foundation for the future and prepares the company for the upcoming departure of the long-standing CEO Peter Ulm. We are delighted that Kai-Uwe Ludwig will now be using his extensive expertise as a project developer, his entrepreneurial talent and his indepth knowledge of international business as a member of the Group Management Board to serve 6B47.

Peter Ulm has done an excellent job in building up the company and decisively shaped the internationalisation of our company. His imminent departure offers us a good opportunity to demonstrate the key importance of the German market for 6B47 also at the top management level in the future."
