New management at 6B47 in Austria

Vienna, 21.05.2021 - The agendas of the Austrian subsidiaries of 6B47 Real Estate Investors AG are managed by a new management duo.

Christian Polak (41) and Christian Wagner (57) have been responsible for the Vienna-based 6B47 Austria GmbH & Co KG and 6B47 Wohnbauträger GmbH (in short: 6B47 Group Austria) since May 2021. Silvia Wustinger-Renezeder's contract as Managing Director of the housing developer ends after five years on May 21, 2021. From now on, she will devote herself to her own projects.

Christian Polak, who has held his position as Managing Director since 2017, has been appointed Spokesman of the Management as part of the reorganization. Christian Wagner has been Head of Transactions at 6B47 since July 2020 and now moves up to 6B47 Group Austria as Managing Director.

After completing his international business studies at the University of Vienna, the native Viennese began his career as a technical project manager classically in the construction industry. His education, experience and international orientation led Polak to today's UBM Development (formerly Strauss & Partner) as Head of Project Development, where he also managed several branch offices in the CEE/SEE region as Managing Director.

Before joining 6B47, Christian Polak held the position of Managing Director at EYEMAXX Real Estate Group in Vienna for three years. Since May 2017, he has been responsible as Operational Managing Director in 6B47 Group Austria.

Ing. Christian Wagner (born 1964)

As part of his many years of development work for the Raiffeisen Group, the trained civil engineer and "Eastern pioneer" held extensive management and project responsibility in the CEE/SEE/CIS region from the 1990s onwards.

In 2011, the native of Lower Austria started his own business in the field of real estate development and consulting.

After ten years, Christian Wagner is taking the next step towards a management position at a project developer operating throughout Europe. The existing obligations within the scope of his self-employment will be fulfilled until the end and at the same time he will gradually resign from the activities and participations not belonging to the 6B47 Group.
